The charge applicable to unauthorized gas use as defined on Leaf No. 337.0 of the

- i) Two times the sum of the market gas price as determined in accordance with the Company's
 Operating Procedures plus the applicable Interruptible or Off-Peak Firm transportation rate; or,
- ii) Nine times the applicable Interruptible or Off-Peak Firm sales rate
