A. Daily Swing Service Demand Charge: \$0.0101 per therm

The Company's weighted average per therm cost of firm pipeline and storage capacity upstream of the city gate used to provide balancing.

- V. Charges applicable to customers served under Service Classification No. 18 and Sellers served under Service Classification No. 19 who have established a Pool of transportation customers which includes Service Classification No. 18 customers.

A. Standby Gas Demand Charge: \$0.0000 per therm

The Company's weighted average per therm cost of pipeline and storage capacity upstream of the city gate in the event a Marketer is no longer able to fulfill delivery commitments to customers.
