The Company's monthly weighted average per therm cost of firm pipeline capacity upstream of the city gate used for balancing.

**A. Daily Swing Service Demand Charge: \$0.0101 per therm**

The Company's weighted average per therm cost of firm pipeline and storage capacity upstream of the city gate used to provide balancing.

**A. Standby Gas Demand Charge: \$0.0000 per therm**

The Company's weighted average per therm cost of pipeline and storage capacity upstream of the city gate in the event a Marketer is no longer able to fulfill delivery commitments to customers.
