- i) Two times the sum of the market gas price as determined in accordance with the Company's Operating Procedures plus the applicable Interruptible or Off-Peak Firm transportation rate; or,
- ii) Nine times the applicable Interruptible or Off-Peak Firm sales rate

E Capacity Release Service

The rate per therm applicable to Capacity Release Service is 6.92 ¢/therm

F. System Loss Factor

The percentage to be applied to a customer's daily transportation quantity to determine the quantity of gas to be retained by the Company as an allowance for losses is 1.20%
