2\* This agreements original term expired in 2008 and was extended for 3 years at that time

3\* This agreements original term expired in 2004 and has been extended on an annual basis since that period

4\* This facility operates only 8 months out of the year the minimum monthly fee is \$1,875 or \$15,000 annually. Any monthly usage above 1,123mcf is billed at the current SC-6 rate of \$1.83/Mcf

5\* Customers Rates are currently \$.30/Mcf on first 1,500Mcf used all remaining volumes used at \$.27/Mcf. Effective 11/1/9 all volumes used at a rate of \$.32/Mcf.

6\* Customers Rates decrease from the SC-7 Tariff Rate of \$.70/Mcf to \$.22/Mcf for all volumes used over the contract minimum. This level is based on the historical average monthly usage at the facility.

7\* Contract does not establish a minimum pressure - 7 inches of W.C. is minimal pressure required. This customer pays a minimum annual fee of \$120,000 plus an annual minimum surcharge fee of \$100,000 After 10 years the customers rate reverts to the SC-6 rate.
