GENERAL TARIFF

STATEMENT OF MUNICIPAL SURCHARGE FOR LOCAL UTILITY GROSS REVENUE TAXES

In the cities and villages listed below, the municipal surcharge shown applies to recurring and non-recurring rates and charges for all intrastate services except toll message usage, WATS, check return and late payment charges. (See Section 1.U of this Tariff)

Services provided by one telephone company to another, to be resold by the second telephone company, are not subject to the municipal surcharge for local utility gross revenue taxes. To be exempt from the municipal surcharge, the reseller must possess a Certificate of Public Convenience and Necessity from the New York State Public Service Commission. Public Telephone Services, as specified in Sections 3.A (Public Access Lines) and 3.B. (Public Access Smart-pay Line Service) of this Tariff, provided to Customer-Owned Coin Operated Telephones (COCOTs), as defined in Section 3.A.3.a. of this Tariff, are not subject to the municipal surcharge. (See Section 1.U of this Tariff)

The tax district codes shown are Telephone Company codes to identify the tax districts in which the subscriber address is located.
