Pursuant to the Commission Order issued in Case 17-W-0528, the under-collected revenues of \$126,310 with \$15,598 in interest associated with the levelized rate increases will be recovered through a 6.923% surcharge applied on all customers' bills on a bills-rendered basis commencing August 1, 2020 through July 31, 2021. The surcharge will expire at the end of Rate Year 3 or at such time the total amount including interest is fully recovered.
