(A) Under the Company's revised "Accounting for the Above Market Fuel Costs for ERRP," submitted by the Company on April 10, 2015 in Cases 09-S-0029, et al, the Company determines whether ERRP electric costs are above or below market annually and then settles that amount between steam and electric. Item 1 of the attached statement reflects steam's recovery from electric of below market electric costs provided by ERRP from October 1, 2022 through September 30, 2023. The amount will be a credit of approximately \$2,156,000 per month from December 2023 through March 2024.
