Dear Secretary Phillips:

On December 16, 2021, the New York State Public Service Commission (the "Commission") issued its *Order Adopting Terms Of Joint Proposal, Approving Stock Purchase Agreement And Long-Term Indebtedness, With Additional Requirements* in the above-referenced proceeding.¹ As relevant here, the Order notes that, following Liberty Utilities (Eastern Water Holdings) Corp.'s purchase of all of New York American Water Company, Inc.'s ("NYAW") issued and outstanding capital stock (the "Transfer"), NYAW's corporate name may change.² On January 1, 2022, the Transfer occurred, and, the next day, NYAW's corporate name changed to Liberty Utilities (New York Water) Corp. ("Liberty Water NY").

On behalf of Liberty Water NY, we write to notify the Commission of this name change and file a copy of the enclosed Certificate of Amendment of the Certificate of Incorporation, which is already on file with the New York State Department of State, Division of Corporations, State Records and Uniform Commercial Code, in the above-referenced proceeding (the "Certificate").³ Moreover, Liberty Water NY confirms that, in accordance with the customer outreach plan that it provided to Department of Public Service Staff prior to the Transfer, it is in the process of

informing its customers of the Transfer, the resulting name change, and the positive changes the Transfer will have on customers' experience moving forward. For example, customers have been provided with the welcome letter,⁴ the next round of water bills will contain an on-bill message regarding the Transfer, and Liberty Water NY has launched a website to provide customers with answers to frequently asked questions and other information. In addition, Liberty Water NY is in the process of rebranding its signage, uniforms, and utility vehicles.

Following this filing, Liberty Water NY will coordinate with the Department of Public Service's tariff group to take appropriate steps to cancel NYAW's existing tariff and file a new tariff in Liberty Water NY's name.



Following NYS Public Service Commission (PSC) approval, we are pleased to announce that New York American Water is now Liberty Utilities (New York Water) Corp. (Liberty). We are very excited to be your water/wastewater provider and are working with New York American Water's former parent company, American Water, to ensure this transition is as smooth as possible.

Liberty is committed to providing safe and reliable service and a great customer experience. We support the communities we serve and strive to create greener, cleaner, and more sustainable systems for the future.

Your Bill Will Decrease.

We are happy to report that Liberty is eliminating the "Make Whole" surcharge effective January 1, 2022. New York American Water was scheduled to implement a rate increase in April 2020, but the increase was delayed in response to the COVID pandemic. The PSC had granted the Make Whole surcharge, which was implemented May 1, 2021, to recover the lost revenue due to this delay. Following the elimination of this surcharge, a typical residential customer using 8,000 gallons/month will see approximately \$6-11 reduction in their bill per month, depending on location.
