### Line Extension Policy

Orange and Rockland Utilities, Inc. (the "Company") will construct and maintain, at no cost to the applicant, up to 500 feet of overhead distribution line extension for each qualified residential applicant for single-phase service, up to 300 feet for each qualified residential applicant for three-phase service. Up to 100 feet of overhead service line will be provided at no cost for residential applicants. Where permitted to provide non-residential overhead service, the cost and expense which the Company must bear shall include the material and installation costs for up to 500 or 300 feet of overhead distribution line, for single-phase and three-phase service, respectively.

An extension of greater length may be built without contribution by residing applicant(s) if the total estimated revenue in each of the first two years of service from all customers on the line extension exceeds 1.5 times the cost of the total distribution line extension. Residing applicants may also choose to make a lump sum payment in lieu of contribution or participate in a surcharge on the line extension. Both methods are reviewed annually and refunds/cancellations made as qualifications are met.

Non-residing applicants must make a contribution equal to the Company's labor and material costs for the excess portion of the line extension as specified in the Company's tariff for overhead line extensions in excess of the free footage.

For mandatory underground line extensions, the free footage allowance is up to 100 feet of underground distribution line. For multiple occupancy buildings, the footage allowance for each building is up to 100 feet of underground distribution line times the average number of dwelling units per floor of each building. The cost of underground line extension in excess of the footage allowance will be calculated using the Company's current cost of trenching, materials and installation. Effective August 1, 2022 the charge is \$33.05 per trench foot for single phase service.

The charge for labor, material and trenching for single-phase service is set forth in the Statement of Underground Residential Distribution Contribution. That statement also sets forth an incremental charge for three-phase service applicable to three-phase trench footage beyond the allowance. Effective August 1, 2022, the incremental charge is \$8.69 per trench foot for all three-phase trench footage, and a charge equal to the Company's incremental costs for appurtenant facilities required to supply the applicant's or Company's three-phase requirements.
