1. The name of the corporation is Alltel New York, Inc. The name under which the corporation was formed is Finger Lakes Telephone Corporation.

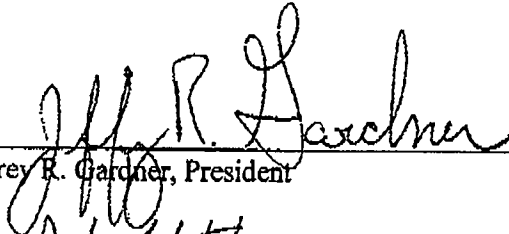
2. The certificate of incorporation was filed by the Department of State on February 25, 1926.

3. The certificate of incorporation is hereby amended to change the corporate name. Paragraph "First" of the certificate of incorporation is amended to read:

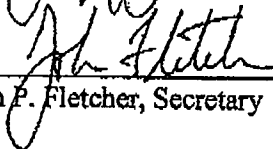
"FIRST. The name of the corporation is WINDSTREAM NEW YORK, INC.

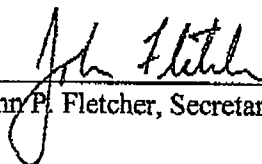

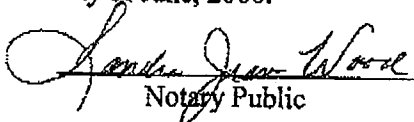

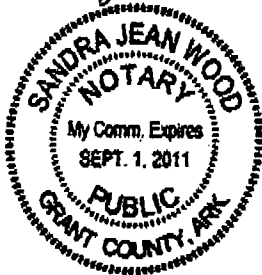
