1.4 APPLICATION OF TARIFF

1.4.1 General

This tariff applies to the furnishing of Local Exchange Services defined herein by AT&T Communications of New York, Inc., (hereinafter referred to as the "Company" or "AT&T"). Local Exchange Services are furnished for the use of Customers in placing and receiving calls within the Local Calling Area. Service will be made available as facilities, ordering, billing, provisioning, and maintenance systems permit.

The provision of Local Exchange Services is subject to regulations, terms and conditions specified in this tariff and the Company's current tariffs each of which may be revised, added to or supplemented by superseding issues.

1.4.2 FLEXIBLE PRICING

A. General

This tariff provides flexible pricing which sets minimum and maximum rates that can be charged for telephone service. Rates may be reduced selectively and in varying amounts.

B. Conditions

1. The Company reserves the right to change rates at any time on one day's notice by filing revised Price List Attachments with the Commission.
2. A change affecting the maximum level will be made in accordance with the applicable New York State Public Service Commission Rules and Regulations.
3. Appropriate notification of changes in the rates for AT&T Local Exchange Service will be made to the Customer.
4. A Consumer rate shall not be changed unless it has been in effect for at least thirty (30) days.
5. A Consumer Customer may request that the Company disconnect service that is provided under flexible pricing due to a rate increase. The Customer will be credited for the difference between the new rate and the old rate retroactive to the effective date of the increase if the Customer notifies the Company of its desire to disconnect service within 20 days of receiving notification of the rate increase.

1.4.3 APPLICATION OF RATES AND CHARGES

A. General

Any subscriber for facilities or service may be required to sign an application form requesting the Company to furnish the facilities or service in accordance with the rates, charges, rules and regulations from time to time in force and effect.

B. Responsibility for Message Charges

The Customer is responsible for all messages sent over the Customer's lines or facilities and for all messages charged to the Customer's lines or facilities where the Customer, or any person answering the Customer's line, agrees to accept such charge(s).
