12.5 Service and Maintenance Charges

12.5.1 Order Change Charge

An Order Change Charge will apply when the Company for performs some alteration to a customer's existing telephone service including moves, adds, changes and disconnects, or for establishing new service.

Non-recurring charge: \$150.00 per change

12.5.2 Expedited Order Charge

An Expedited Order Charge will apply when a customer requests a service date that is earlier than the standard interval service date for the service ordered. The request for an earlier service date may be received from the customer prior to the issuance of an order, or after the order has been issued but prior to the service date. Broadwing 's acceptance of an expedited order is not a guarantee, implied or otherwise, that the service will be installed on or before the customer's requested date. If Broadwing accepts an expedite order and does not meet the customer's requested date, the expedite order fee will be refunded.
