GENERAL TARIFF

SWITCHED NETWORK ACCESS PORT SERVICE

A. GENERAL

1. Definition

Switched Network Access Port Services (SNAPS) offers a customer the capability to connect port services for exchange access services offered in this section to the transport facilities of an interconnector, as defined in Part B of the Product Guide; to a *Superpath* 1.5megabit/sec service Central Office Multiplexer subscribed to by a customer from Part B of the Product Guide.

2. Links and Ports

The interconnector–provided facilities of Paragraph A.1 preceding are referred to as “links.” “Ports” are central office switching points that provide access to the public switched network for various classes of exchange access service.

3. Choice of Link Provider

A customer may chose the Company as its link provider or purchase a link provided by an interconnector. If the customer chooses the Company as its link provider, the regulations, rates and charges, as set forth in the applicable full service tariff sections, will apply. The Company’s full service offerings corresponding to the port services included in SNAPS are referenced in Paragraph A.7. following.

4. Port Rate Element

A customer choosing the provision of exchange access services with interconnector–provided links or for connection to Central Office Multiplexers must purchase the Company’s port services from this section subject to the rates, charges and regulations specified herein.

5. Interconnection

When associated with interconnector service, the interconnection is made to interconnector–provided fiber optic facilities and equipment located in Telephone Company central offices/wire centers or interconnector–provided terrestrial point to point microwave facilities, equipment and support structures located in, on or above the exterior walls and roof of those Telephone Company central offices/wire centers (collocation), listed in the National Exchange Carrier Association Inc. (NECA) Tariff F.C.C No.4. The associated collocation tariffs are Optical Transport Interconnection Service (OTIS) II specified in Section 6.C of this Tariff and Microwave Transport Interconnection Service (MTIS) specified in in Section 6.D of this Tariff.

6. SNAPS

Service Provision - In those instances, where a customer purchases a link provided by an interconnector, SNAPS is provided subject to the availability of facilities and service offerings in the central offices where the interconnector’s equipment is located. Similarly, in those instances where a customer chooses to utilize Company-provided multiplexing services, SNAPS is provided subject to the availability of facilities and service offerings in the central office where the Central Office Multiplexer is located.

8. Flexpath Wire Center Number Retention Service

Flexpath Wire Center Number Retention Service provides an interconnector with the ability to have existing central office telephone numbers converted to DID numbers. The converted numbers will then be aggregated into a DID-type service and directed to designated Flexpath Digital PBX Port Service trunk groups in the same switch. The trunk groups can be connected to the interconnector's facilities.

B. REGULATIONS

1. Applicability of Port Service Rates

For port services, the service descriptions, rules, regulations, definition of terms, standard features, optional features, feature descriptions, non-recurring charges, service connection charges, installation charges, other rates and charges, service period plans, service discount plans, multi-year contracts, rate stability plans and termination charges specified in the tariff sections referenced in Paragraph A.7. preceding apply, except for the following:

- a. Full service monthly rate elements specified as port service rate elements in this section.
- b. When port services non-recurring, installation, service establishment or service connection charges are different than those for the corresponding rate elements of the full service, the port service charges stated in this section of the tariff will apply.
- c. (1) When the term "line" is used in the full service tariffs to represent a link between the central office and the subscriber's premises, it shall also be interpreted to represent an interconnector provided link to a customer's port service when applicable, except in the case of Telephone Company facilities being used to provide transport facilities for port service optional features.  
  
(2) When the term "line" is used to represent full service, i.e., link and port, it shall also be interpreted to mean a port as specified in this section of the tariff.  
  
(3) When the term "line" is used to represent total quantities for a specific class of service it shall have a dual meaning as discussed in Paragraph B.1.c.(2) preceding.
- d. Rates and charges for C.O. loops and digital transport facilities (the local transport facilities elements) will apply only to the extent that Telephone Company facilities are used.
- e. The port service customer will not be subject to full service tariff mileage charges, to the extent an interconnector provides the link associated with the mileage charge or the port service is connected to a Central Office Multiplexer or IAS Transport Package 1, 3 or 12 Local Distribution Channel subscribed to by a customer. Mileage charges for Superpath 1.5 megabit/sec service, as specified in Part B of the Product Guide, may apply.

2. Service Access Charges

For each interconnection of a port service included in this section, interconnectors will be assessed a Service Access Charge as specified in Section 14.6 of this Tariff.

3. Universal Service Element

A Universal Service Element (USE) as specified in Section 14.6 of this Tariff is applicable to specific port services as a charge to the interconnector.

4. End User Common Line Charge

End User Common Line (EUCL) charges, as specified in F.C.C. No. 11, do not apply when a customer subscribes to a port service pursuant to this section and when the Company does not provide the transport facilities.

5. Termination Liability

Termination liability charges are not applicable for a conversion from a port service to full service.

6. Service Connection Charge

For conversions from a full service to a port service or from a port service to a full service, service connection charges apply as specified in Section 14.7 of this Tariff.

7. Feature Limitations

Certain Port Services - Intellipath II ports equipped with Electronic Telephone Service (ETS) features and all Digital Automatic Call Distribution II ports, except the agent and supervisor non-electronic feature package port cannot be provisioned via the Superpath 1.5 megabit/sec service Central Office Multiplexer.

8. Flexible Pricing Plan

This service is subject to the Flexible Pricing regulations set forth in Section 1.A.8 of this Tariff, except as otherwise provided below.

- a. Flexible pricing is applicable to the port services in Paragraphs B.8.b., c., and d. following.
- b. Intellipath Digital Centrex Port Service, Intellipath II Digital Centrex Port Service (5-99 Lines), Digital Automatic Call Distribution II Port Service, ISDN Primary Port Service, and NYNEX Digital Centrex Plus Port Service (Centrex Plus Port Service) rates may be decreased, selectively and in varying amounts, so long as the rates cover their relevant costs.

8. Flexible Pricing (Cont'd)

- c. SWITCHWAY Port Service rates may be decreased, selectively and in varying amounts, so long as the rates cover their incremental costs.
- d. The month-to-month rate for Flexpath Digital PBX Port Group Service may be decreased, selectively and in varying amounts, so long as the rate covers relevant costs.
- e. All flexibly priced port service rates may be increased selectively and in varying amounts not to exceed 25 percent per year.
- f. The month-to-month rate for Flexpath Digital PBX Port Group Service may be increased, selectively and in varying amounts, not to exceed the maximum rate filed.
- g. Changes in port service rates will be applied on the date the new rates become effective.
- h. Port Service rates may be changed in accordance with the preceding provisions, on a wire center by wire center basis.
- i. Flexible pricing is not applicable to port service rate stability plans.
- j. Port rates will only be changed when the Company changes the full service rates by the same amount.

9. Assignment Control

The Company retains the right to maintain assignment control to the point of termination.

10. Interconnector's Responsibilities

- a. The customer's selected interconnector will be responsible for notifying the Telephone Company of significant outages which could impact or degrade the Company's switches and service, and for providing the estimated clearing time for restoral.
- b. The customer's selected interconnector is responsible for coordinating with the Company to ensure that services are installed in accordance with the service request.
- c. The customer's selected interconnector is responsible for testing, if necessary, with the Company to identify and clear a trouble when the trouble has been sectionalized (isolated) to the interconnector provided service.
- d. The customer's selected interconnector is responsible for providing a contact number that is readily accessible 24 hours a day, 7 days a week.

10. Interconnector's Responsibilities (Cont'd)

- e. The customer's selected interconnector is responsible for providing trouble report status when requested.
- f. The customer's selected interconnector will be responsible for providing the current service address for all customers of the interconnector for the purpose of the provisions of emergency service.
- g. The suspension/ termination of an interconnector for nonpayment or for cause other than nonpayment as described in Section 1.J.9. of this Tariff. will result in the suspension/ termination of any customer of a port or ports offered pursuant to this section who has selected said interconnector for provision of links. The Company will notify the affected customers prior to the suspension/ termination date to advise them their options: disconnect or select the Company or another interconnector for provision of their links.
- h. When an interconnector subscribes to Flexpath Wire Center Number Retention Service, port service must be obtained from Flexpath Digital PBX Port Group Service. The Company, upon request, will convert an existing central office telephone number to a DID number and direct the number to a trunk group designated by the interconnector. The interconnector may add additional DID numbers to the number range previously established as long as the numbers conform to the DID number regulations found in Part B of the Product Guide. When a number to be converted is outside the range of previously established groups of numbers, a new group of twenty numbers must be established. Flexpath Wire Center Number Retention Service is offered on an intra-switch basis only.

C. RATES AND CHARGES

For Rates and Charges, see Section 14.12 of this Tariff.
