## SECTION 1 – BASIC LOCAL SERVICE

### A. INDIVIDUAL LINE SERVICE

Exchange service is the provision to the customer, either residence or business to the exchange network for the purpose of making and receiving calls at tariffed rates. Exchange service is available in the types and grades listed in this section at the rates listed. These rates are for customers located within the base rate area.

#### 1. Grade of Service

##### a. Individual Line Service

Individual Line Service is the grade of service providing a central office line for one specific customer only. Two or more lines of the same customer may be grouped together for incoming service if the lines are served from the same central office and terminate at the same premises.

##### b. Multi-Premises Service

Multi-Premises Service is the grade of service providing a central office line at two or more non-contiguous customer premises. Multi-Premises Service is provided on an individual Line basis only at individual line rates per location.

#### 2. Types of Local Service

##### a. Flat Rate Exchange Service

Flat Rate Service is provided at a monthly rate with an unlimited number of calls within a specific local calling area. The local calling area for each exchange is specified in this section. Flat Rate Service is offered on both individual and party line service unless stated otherwise.

2. Types of Local Service (cont'd)

b. Message Rate Exchange Service

1. Message Rate Exchange Service is provided at a monthly rate either with a specific dollar allowance for local calls or with no allowance. Charges for each local call can be found in this tariff. Message Rate Exchange Service is offered only on individual lines. The following is the only type of Message Rate Service Available.

Un-timed Message Rate

Charges are on a per call basis to local calling area numbers and are un-timed.

3. Timing of Local Calls

- a. Chargeable time periods begin when the connection is established, that is, when the called number is answered.
- b. Chargeable time periods end when either the calling station or the called station hangs-up, thereby releasing the network connection.
- c. Chargeable time periods do not include time lost because of faults or defects in the service.
- d. Initial and overtime chargeable time periods apply on calls to points outside the primary local calling area and within the extended local calling area.
- e. Initial and overtime chargeable time periods do not apply to local calls from flat rate customers.
- f. When the exchange service is connected to a customer-provided communications system through a terminating arrangement or connecting arrangement under the provision of this tariff, chargeable time begins when a call from the telecommunications network terminates in or passes through the first multi-line terminating system or terminal equipment on that communications system. It is the customer's responsibility to furnish appropriate answer supervision to the point of connection with the exchange telephone service so that chargeable time may begin.

3. Base Rate Area Boundaries:

- Hilton            The Base Rate Area of the Hilton Exchange comprises of the territory within the village limits of Hilton and beyond as follows: commencing at the intersection of Hilton Parma Corners Road and Burritt Road, extending in a westerly direction to a point on Burritt Road just west of Hill Road and thence north to a point just west of the intersection of Collamer and Dunbar Road; and then east along Dunbar road to the intersection with North and then southeasterly to Bennett Road approximately 350 yards north of its junction with Salmon Creek and thence south to the intersection of East Avenue and Wilder Road; and then south for a distance of about 3/4 mile to Buttonwood Creek and then in a southeasterly direction to an intersection with Burritt Road .1 mile east of Butcher Road and thence southeasterly to an intersection with Manitou Road .1 mile north of Latta Road and thence southeasterly to an intersection with Latta Road .4 miles east of Manitou Road and then easterly along the north side of Latta Road to the boundary with Rochester Telephone Corporation and then southwesterly along the boundary to an intersection with Peck Road and then westerly along the south side of Peck Road to a point .3 miles west of Manitou Road and then north .3 miles and then northwesterly to an intersection with Parma Center Road .1 mile west of Bailey Road and then northwesterly to an intersection with Butcher Road .4 miles north of Parma Center Road then northwesterly to an intersection east along the south side of Burritt Road to the intersection with Hilton Parma Corners Road.
- North Chili        The territory within the following limits: commencing at the junction of the exchange boundary and Westside Drive, extending in a northeasterly direction to a point just northwest of the intersection of South Union Street and Stony Point Road, and then in an easterly direction along the north side of Stony Point Road to the intersection of Buffalo Road and Whitter Road and then 4148 feet north along the west side of Whitter Road and extending 3140 feet in a northeasterly direction to a point 2965 feet north of the intersection of Statt Road and Manitou Road and continuing in an easterly direction to the exchange boundary.

3. Base Rate Area Boundaries:

Spencerport

The territory within the village limits of Spencerport and beyond its limits as follows: commencing at the intersection of Colby and Union Streets and then on a line diagonally to the north and west to a point intersecting Brockport Road, just east of Trimmer Road; thence in a northerly direction to Town Line and thence in an easterly direction on the north side of Town Line Road to a point approximately 350 yards beyond the intersection of Town Line Road and Union Street; thence diagonally in a southeast direction to Canal Road approximately three-quarters of a mile east of Union Street and thence south one-half mile to Lyell Avenue; thence south and easterly to the intersection of Gillette Road and thence south to Nichols Street; then westerly on the south side of Nichols Street for approximately one mile then southwest diagonally to the intersection of Union Street. Starting at point 210' east of Gillett Road center line on north R.O.W. line of Shepard Road, thence northerly 1667' to a point, thence easterly 3868' to a point north of Rt. 531, thence easterly along the northern R.O.W. line of Rt. 531 to a point on the company's eastern franchise line, thence southerly along the eastern franchise line to the North Chili exchange boundary, thence westerly 3488' to a point, thence northerly 2885' to a point just east of Shepard Lane on north R.O.W. of Shepard Road, thence westerly along north R.O.W. line of Shepard Road to point of beginning.
