3.7 Rate Regulations

(A) The Transitional Charges will be billed per access minute to each customer Switched Access Service provided under this tariff. (C)

(B) The access minutes which are used to determine the Transitional Charges will be accumulated using call detail recorded by Telephone Company equipment. The Telephone Company measuring and recording equipment will be associated with end office or local tandem switching equipment and will record each originating and terminating access minute where answer supervision is received. The accumulated access minutes will be summed by end office, and then rounded to the nearest minute. (C)
