1.1 Description

1.1.10 Amended Rates, Charges, and Regulations Issued on September 7, 1999

- A. The amended rates, charges, and regulations are filed in compliance with the PSC's Opinion and Order No. 99-10, issued in Case No. 99-C-0529 on August 26, 1999. These changes are without waiver of, or prejudice to, the Telephone Company's rights and objections with respect to such opinion and order. Specifically, but without limitation, it is the position of the Telephone Company that Internet traffic should not be subject to reciprocal compensation arrangements such as those set forth in this tariff. This position is being asserted in, among other forums, a pending action in the United States Court of Appeals for the District of Columbia Circuit. Furthermore, pursuant to Ordering Paragraphs 1 and 2 of Opinion and Order No. 99-10, the amendments filed on September 7, 1999 shall take effect on a temporary basis, subject to refund or reparation, except as otherwise provided in the amendments themselves.
