ii. Conditions and Limitations

- a. The rules, regulations, and limitations as specified in Sections 1 and 7 of the New York State Telecommunications Association, Inc. P.S.C. No. 2 - Telephone for Residential One-Party Line and Feature services will apply as part of this package.
- b. Champs Choice Package is only available to those customers that also subscribe to the Champs Choice package or Champs Choice Plus Package as it appears in the PrimeLink, Inc. PSC No. 1 -Telephone Tariff and Primelink Champs Choice DSL Product.
- c. Champs Choice Package applies per telephone line at a single location within the Company's service territory.

ii. Conditions and Limitations

- d. Unless terminated via a mutual agreement between the Champs Choice Package customer and the Company, a customer will remain enrolled in the Package, as amended from time-to-time, with any applicable changes in rate, for as long as the Package continues to be offered by the Company.
- e. Service Charges, as described in Section 3 of this tariff, apply to requests for new and additional Champs Choice Package lines, and moves of existing lines. Service Charges will not apply when the Champs Choice Package replaces an existing Local Exchange Service or if the customer requests to switch to Local Exchange Service after the Package has been terminated.
- f. Champs Choice Package customers are not eligible for any other packages, discounts or promotional offerings associated with the Services included in the Package, unless specifically provided for in a promotional offering.
- g. Customers enrolled in the Package, who fail to pay the entire rate per month, will have all existing Champs Choice Package services converted to the applicable tariff a-la-carte rates. Service Charges will not apply for converting services back to tariff rates. Such customers will not be permitted to re-enroll in this Plan until such time as all associated unpaid balances are satisfactorily paid in full.
