SERVICE CLASSIFICATION NO. 4 (Continued)

b. For customers served at Primary voltage delivery levels (2.2-15kV) whose parent delivery service classification is Service Classification 3 and for whom non-NYPA electric demand accounted for 15% or less of their electric demand during the time period July 1, 2010 through June 30, 2011, the following discounts off of the full standard tariff rates that are otherwise in effect at each date noted below, will go into effect on the following dates:

- i. Prior to January 1, 2012, \$1.52 per kW-month of contract demand.
- ii. January 1, 2012 through December 31, 2012: 65% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- iii. January 1, 2013 through December 31, 2013: 55% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- iv. January 1, 2014 through December 31, 2014: 45% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- v. January 1, 2015 through December 31, 2015: 35% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- vi. January 1, 2016 through December 31, 2016: 25% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- vii. January 1, 2017 through December 31, 2017: 15% discount off of the distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.
- viii. January 1, 2018: Then-existing delivery rates will be increased to the same level as the then-existing distribution delivery rates for the customer's Parent Service Classification No. 3 otherwise in effect at that time.

Existing Allocations are defined in Special Provision M below.

2. **Additional Allocations.** Distribution delivery rates for Additional Allocations of Expansion Power shall include the rates set out above for Existing Allocations plus an additional charge determined by multiplying the difference between that transmission service charge and the total delivery charges for New Allocations set out below by the following percentage amounts:

-	through 10/31/2007	0%
-	11/1/2007 through 10/31/2008	20%
-	11/1/2008 through 10/31/2009	40%
-	11/1/2009 through 10/31/2010	60%
-	11/1/2010 through 10/31/2011	80%
-	11/1/2011 through 12/31/2011	100%
