##### 3.7.63 Block of Time Term Agreement Plans

Business Customers that subscribe to a Block of Time Term Agreement Plans travel to this State and bill intrastate calls to their calling card will pay the Calling Card Option 2 rates specified in Section 1.7.63 of this Tariff in lieu of the Calling Card Option 2 rates specified in Section 1.2.1(A) and 1.2.1(C) of this Tariff

##### 3.7.64 AT&T Business Unlimited Calling<sup>SM</sup> III

Business Customers that subscribe to AT&T Business Unlimited Calling<sup>SM</sup> III, travel to this State and bill intrastate calls to their calling card will pay the Calling Card Option 2 rates specified in Section 1.7.64 of this Tariff in lieu of the Calling Card Option 2 rates specified in Section 1.2.1(A) and 1.2.1(C) of this Tariff
