4.1.3 Regulations

- Α. The Company reserves the right to determine deployment locations for this service.
- B. Frame Relay technical publications may be obtained by contacting the Company.
- C. Frame Relay Service installation is subject to service connection charges as specified in PSC NY No. 1—COMMUNICATIONS Tariff, Section 30.14.

- Existing private line circuits provided by the Company or another carrier may not D. be used to connect to FRS unless otherwise specified by the Company.
- E. All UNI Port with Access Line Connections, UNI Port Only Connections and NNI Port Only Connections provided on a month-to-month basis are subject to a minimum service period of one month. Additional Logical Channels are offered on a month-to-month basis only.

Effective May 6, 2003, the 7-year service period plan for 56 Kbps, 384 Kbps and 1.536 Mbps UNI Port With Access Line Connection is no longer available to new customers. Customers currently subscribing to the 7-year service period plan will be allowed to retain that plan until the end of the 7-year service period.

Effective November 1, 2003, UNI Port With Access Line Logical Channels and Additional Logical Channels for 56 Kbps, 384 Kbps, and 1.536 Mbps Month-to-Month, 3-year and 5-year service period plans is furnished to existing customers only. No longer available to new customers. Additions, rearrangements, and moves are not permitted. Logical and Additional Logical Channels are available to new and existing Enterprise Service customers.

- F. At the conclusion of a selected service period plan, a Customer may cancel FRS, subscribe to another service period plan, or subscribe to FRS at then-applicable month-to-month rates. If the Customer does not execute a new service period plan or cancel FRS upon expiration of the existing plan, then-applicable monthto-month rates will apply.
- G. If a Customer adds service components to an existing FRS, the Customer may subscribe to these components on a month-to-month basis or under a new service period plan.
- Н. A Customer who purchases FRS at month-to-month rates may at any time convert FRS to a service period plan by paying a record order charge and the applicable service period plan price in effect at that time. The effective date of this change will be the first bill date following receipt of the service order requesting the service period plan.
