59. TEMPORARY DEFERRAL RECOVERY SURCHARGE

59.1 Pursuant to the Order of the Public Service Commission ("Commission") dated January 24, 2011 in Case No. 10-E-0050, commencing January 1, 2012, the Company was directed to establish a surcharge for recovery of its deferral accounts. The charges below, by service classification, establish factors for PSC No. 220 and PSC No. 214. The rates below will remain in effect until such time as the Commission determines otherwise.
