S. WEEKEND CHOICE® PLAN

(THIS PLAN IS FURNISHED TO EXISTING SUBSCRIBERS ONLY. MOVES ARE PERMITTED ONLY IF A TELEPHONE NUMBER CHANGE IS NOT REQUIRED).

1. General

The Weekend Choice® Plan is an optional calling plan which is available to individual residence subscribers. The Plan permits subscribers to place directly dialed intrastate intraLATA message toll or interregion calls at fixed rates per minute Monday through Friday and on weekends. A Monthly Minimum Usage Charge applies to weekday usage when it falls below the selected Monthly Minimum Usage Charge shown in the Rate Schedule.

2. Regulations

- a. The Weekend Choice Plan is available to individual line residence subscribers located within the Company's service area in the State. The Weekend Choice Plan is not available to subscribers located within Independent Local Exchange Carriers service areas.
- b. The Weekend Choice Plan applies to an individual residence line customer's monthly minutes of qualifying usage for a particular telephone line at a single location. Weekend Choice Plan usage consists of intraLATA message toll or interregion calls that originate over a particular telephone line at a single location and that satisfy all of the following requirements: (a) the call must be originated within the operating territory of the Company, in New York State, (b) the call must be carried by Verizon New York Inc. and billed by or on behalf of Verizon New York Inc. to the customer participating in the Plan, (c) the call must be dialed and completed without the assistance of a Company operator. However, Weekend Choice Plan usage does not include any of the following: (a) collect calls, calling card calls, person-to-person calls, and all other types of operator-handled calls, (b) calls to a chatline service under NY PSC Orders and calls to any information service including calls placed to 700, 800, and 900 Services; (c) calls associated with any other optional calling plan, (d) local calls and (e) ISDN lines.
- c. Qualifying usage under this Plan applies to the portion of calls occurring during the following hours:
 - (1) Weekday Calls - The weekday period begins at 12:00 A.M. on Monday and goes through 11:59 P.M. on Friday.
 - (2) Weekend Calls - The weekend period begins at 12:00 A.M. on Saturday and goes through 11:59 P.M. Sunday.
 - (3) Holidays will be treated in the rate period they occur; that is, holidays occurring on a Monday - Friday are considered weekday and holidays occurring on a Saturday or Sunday are considered weekend.
- d. When a message is established in one call period and ends in another, the rate in effect in each call period applies to the portion of the message occurring within that call period. In the event that a minute of use is split between two call periods, the rate in effect at the start of that minute applies.
