- 2. Regulations (Cont'd)
 - d. Econopath Calling Plan Service, Virtual WATS, Large Volume Discount Plan and the NYNEX Business Link Plan cannot be established in the calling areas which qualify for discounts under Rewarding Connections. Econopath Calling Plan Service, Virtual WATS, Large Volume Discount Plan and the Business Link Plan must be discontinued for the BTNs subscribing to the local and/or toll option of the Rewarding Connections plan. However, the aforementioned Plans may be established under Rewarding Connections for the local only portion.
 - e. BTNs of residential service will not be included.
 - f. If a customer migrates toll usage from another optional calling plan to a previously established Rewarding Connections plan which includes only local usage, the Rewarding Connections plan will then include both local and toll usage, and the plan date under the established plan will continue to apply for purposes of determining the customer's plan year and aggregate percentage discount. If a customer who has not previously established a Rewarding Connections plan wishes to establish such a plan and to include in it toll usage previously covered by another optional calling plan, the customer will be treated as a new subscriber to Rewarding Connections for purposes of determining plan year and aggregate percentage discount. For purposes of this Paragraph f., "toll" usage means Interregion Regional Call Plan calls, WATS 800 IntraLATA calls, Toll-Free Service calls, Toll-Free Discount Plan calls and Toll-Free Term Plan calls.
 - g. If a customer participating in the plan adds lines to the plan that were previously included in BTNs that are not included in the plan or if a customer participating in the plan adds additional BTNs to the plan, the base period qualifying usage charges and the Minimum Commitment will be increased by the annualized amount of qualifying usage charges of the additional lines or BTNs. The annualized amount of qualifying usage charges of the additional lines or BTNs shall be determined using the method for calculating annualized base period qualifying usage charges specified for Enrollment Option 1. If the additional lines or BTNs had no prior qualifying usage charges, the base period qualifying usage charges and the Minimum Commitment will remain unchanged.
 - h. Rewarding Connections discounts will be provided to customers and applied as specified in Paragraph M.3. The customer must sign a Letter of Commitment subscribing to the plan for a commitment period from one to five years long and selecting an Enrollment Option. The Company will apply the aggregate discount on all BTNs each month based on the assumption that the customer has achieved in that month the monthly equivalent of 100% of its base period qualifying usage charges.
 - i. Effective with this Tariff amendment, existing plan customers will have the option of including toll usage as qualifying usage for discounts under the plan. The customer must sign an amendment to the Letter of Commitment to include toll usage under their existing plan.
