6. <u>ECONOPATH CALLING PLAN SERVICE</u> (Cont'd)

CHANGES ARE NOT PERMITTED.)

## c. Regulations

- (1) Each block of time subscribed to by the customer covers usage only in the Rate Band(s) selected.
- (2) A customer may subscribe to one or more calling bands in any combination.
- (3) The charge applicable for the initial block of time (4, 25 or 50 hours) is a monthly minimum charge. The initial block of time and additional usage rates are billed in arrears.
- (4) The local call allowance where applicable to residence message rate service does not apply to calling in the Rate Band(s) selected.
- (5) Subscribers to Residence ECP I may also subscribe to Residence ECP II for any Rate Band(s) not covered by Residence ECP I. Subscribers to Residence ECP II may subscribe to Residence ECP I for any Rate Band(s) not covered by Residence ECP II.
- (6) The time at which the connection is established determines whether Residence ECP II rates or standard tariff rates apply for the entire call.
- (7) Local calls to Rate Bands other than those subscribed to under ECP Service are charged for at standard tariff rates.
- (8) Only directly dialed station-to-station calls within the applicable local calling bands that originate from the subscriber's telephone are included in the ECP blocks of time.
- (9) Evening and Night rate period discounts do not apply to calls in the plans.
- (10) ECP Service is furnished for a minimum period of one month.
- (11) All local calls covered under a plan made over any line of a multiline subscriber with one billing number are charged for at ECP rates.
- (12) A customer may subscribe to ECP Service for each separately billed number.
- (13) Changes to or from ECP Service or changes in plans for existing subscribers may be effective only on the subscriber's bill date.
- (14) The initial block of time rate may be prorated only when telephone service is connected, disconnected or temporarily suspended during a billing period.
