5.1 Wide Area Telephone Service (WATS)*

5.1.2	Description
D.	Dedicated Toll Free Service (DTFS) — Unless otherwise specified herein, provides facilities for dial type telephone communication to a DTFS access line from intraLATA local and toll points within NY State in accordance with the regulations and schedules of charges as specified in this tariff.
E.	DTFS InterLATA — InterLATA dial type telephone communication to a DTFS access line is furnished by an IC. Any IC may provide interLATA service subject to the availability and compatibility of the facilities of the Telephone Company and of the IC. Since interLATA calls cannot be prevented from reaching a DTFS number, the customer subscribing to intraLATA DTFS must also subscribe to an interLATA DTFS or similar service provided by an IC.
F.	Dedicated NXX Toll-Free Service (DNXX-TFS) — An interim service through which a WATS access line is furnished for use by an IC in providing both intraLATA and interLATA incoming dial type telephone communication service at the IC's WATS-like rates. DNXX-TFS will be withdrawn when DTFS with ten digit identification capability is offered.
G.	Dial type telephone communication as specified for outward WATS or DTFS is a call dialed by the subscriber from his outward WATS access line or an incoming call dialed to a subscriber's DTFS access line, except that if facilities are not available for dial completion, the call may be placed with a common carrier operator. The call may also be placed with a common carrier operator in the same manner if the subscriber for any reason cannot reach a dialed station.
H.	<p>Outward WATS is provided under one or more of the following service arrangements, however DTFS is available only under Service Arrangement A, and DNXX-TFS is available only under Service Arrangement D. ICs have the option of designating one or more of the service arrangements when ordering WATS access lines for use by ICs.</p> <ol style="list-style-type: none"> Service Arrangement A— IntraLATA usage is billed at the WATS rates set forth herein; interLATA usage is billed at the WATS or WATS-like rates of the IC providing interLATA service. Service Arrangement B— IntraLATA usage is billed at the WATS rates set forth herein; interLATA usage is billed at other than WATS or WATS-like rates (e.g., toll-type rates) of the IC providing interLATA service. Service Arrangement C— IntraLATA usage is billed at charges for local and toll calls specified in the Telephone Company's tariffs; interLATA usage is billed at the WATS or WATS-like rates of the ICs providing interLATA service. Service Arrangement D— IntraLATA and interLATA usage is billed by the IC providing the service at the IC's WATS-like rates.
