TERMS OF PAYMENT:

Service construction costs, inspection fee and minimum charge, payable on acceptance of application for service, and thereafter minimum charge payable on or before May 1.

Charge for water consumed in excess of amount paid by minimum charge, payable on presentation of bill. If the bill is not paid within twenty days after presentation, service may be discontinued after proper notice as required by law.

A late payment charge to be computed at the rate of 1.5% per month, compounded monthly, may be applied to all unpaid balances no sooner than 23 days from the mailing of the bill.

TERMS:

Season - May 1 to November 1.

Bills rendered at the above rates are subject to surcharges, surcredits and adjustment clauses as contained elsewhere in this tariff.
