- B. Calculation of Charges - To calculate the monthly recurring charge for an IOC, first determine the airline mileage between AT&T central offices (see Calculation of Airline Mileage, Section 4). Using the appropriate IOC rate for the service ordered, multiply the total airline miles by the mileage rate. To this figure, add the fixed rate for the service. The sum of the mileage rate and the fixed rate is the total monthly charge for the IOC.

Example:

A Customer orders four ASDS 64 kbps channels between AT&T central offices that are 273 miles apart.

273 x the per mile rate for a 56/64 kbps Channel (\$0.34) x 4

\$ 371.28

Add the Fixed Rate (\$261.22) x 4

\$1,044.88

Total Monthly IOC Charge

\$1,416.16
