Terms of Payment

Bills shall be rendered net cash, January 1st, April 1st, July 1st and October 1st, in advance, and are due and payable upon receipt. Bills not paid within 23 days of mailing are delinquent and the late payment charge becomes applicable and service may be discontinued after proper notice as required by law.

Late Payment Charge
