- 2. **The Projected Monthly Hedging Costs / Credits** per therm for Service Classification No. 4A shall equal the Projected Monthly Hedging Costs / Credits per therm for Service Classification Nos. 1A, 1AR, 1B, 1BI, 1BR, 1B-DG, 2, 3, 4A, 4A-CNG, 4B, 7, 14 and 21 as set forth on Leaf No. 75 multiplied by the Factor of Adjustment.
- 3. The Projected Unitized Fixed Cost of Gas for Service Classification No. 4A, shall be equal to 4.27 cents per therm..
- 4. The Off-system Revenue Credits and Marketer Capacity Credits per therm for Service Classification No. 4A shall equal the sum of Off-system Revenue Credits and Marketer Capacity Credits projected for the upcoming Gas Cost Year divided by the sum of the Company's Annual Forecasted Firm Sales and projected annual billed sales for Service Classification Nos. 4A, 4A-CNG and 4B
- D. Monthly Cost of Gas for Service Classification No. 4A-CNG
 Pursuant to the Commission's Order in Case 02-G-1644 dated August 4, 2004, the rates for gas service under Service Classification No. 4A-CNG shall include each month the Monthly Cost of Gas for Service Classification No. 4A-CNG.

The Monthly Cost of Gas for Service Classification No. 4A-CNG shall be computed in advance of each Effective Month as the sum of: (1) the Projected Monthly Unit Commodity Cost of Gas per therm for Service Classification No. 4A-CNG **PLUS or MINUS**, (2) the Projected Monthly Hedging Costs / Credits per therm for Service Classification No. 4A-CNG, **PLUS**, (3) the Projected Unitized Fixed Cost of Gas per therm for Service classification No. 4A-CNG **LESS**, (4) the Off-system Revenue Credits and Marketer Capacity Credits per therm for Service Classification No. 4A-CNG.
