CALENDAR MONTH RATE:

The Calendar Month Rate per Dt, determined at the sole discretion of the Company, will be not less than the Adjusted Commodity Cost of Gas and not more than the Firm Gas Price. The Contract Facilities Charge is \$895.78.

NOTIFICATION OF RATE:

The Company will notify customers served under this Service Classification of the Calendar Month Rate not less than three (3) days prior to the month (except as provided for under Special Provision 9) for which such Calendar Month Rate will apply. Notification shall be made by a Statement of Calendar Month Rate, which shall also contain the Equivalent Gas-Oil Price, the Adjusted Commodity Cost of Gas, the Firm Gas Price and a price for gas taken under the terms of Special Provision 5, below, equal to the stated rate in effect at the time plus the currently effective rate per Dth of unauthorized usage in accordance with Rule 3.3.1 of this schedule. Such Statement of Calendar Month Rate will be duly filed with the Public Service Commission, apart from this Schedule, not less than three (3) days before the beginning of the month (except as provided for under Special Provision 9) for which such rate will be in effect, and will be available to the public at Company offices at which application for service may be made.

INCREASE IN RATES AND CHARGES:

The rates and charges under this Service Classification will be increased by a tax factor pursuant to Rule 19.

CALENDAR MONTH MINIMUM CHARGE:

The Calendar Month Minimum Charge is equal to the Contract Facilities Charge plus the dollar amount resulting from multiplying the Minimum Billing Quantity times the difference between the Calendar Month Rate exclusive of applicable gross revenue taxes and the Commodity Cost of Gas.

MINIMUM BILLING QUANTITY:

In any calendar month, the Minimum Billing Quantity of gas shall be 720 Dt; the Minimum Billing Quantity will be adjusted, as applicable, to reflect the duration of any interruptions of service under Special Provision 4, below.

BTU ADJUSTMENT:

Volumes of gas registered at the customer's meter, in Ccf, will be adjusted for Btu content, in Therms, as stated in Rule 14.3.
