A Capacity Release Seller may elect to participate in Con Edison's Capacity Release Service ("The Program"), subject to the terms and conditions in this Tariff and the Company's Sales and Transportation Operating Procedures Manual ("GTOP").

(A) Availability of Released Capacity:

A Capacity Release Seller may elect to obtain a portion of the Company's available interstate pipeline capacity to serve its Firm Customers commencing November 1, and extending to October 31 of each year (the "capacity release period"). Deadlines for making a binding commitment and for executing a Capacity Release Service Agreement for each capacity release period will be communicated directly to Capacity Release Sellers or will be set forth in the Company's GTOP.

A Capacity Release Seller may obtain Capacity Release Service as of November 1, 2006, for either the sum of the Maximum Daily Quantities ("MDQs") of all its Firm Transportation Customers ("total MDQs") or for less than the sum of the MDQs ("partial MDQs") of all its Firm Transportation Customers.

(B) Increasing or Decreasing Released Capacity

Prior to the 2007-2008 capacity release period and for each subsequent release period thereafter, Capacity Release Sellers may request increases or decreases to their prior capacity release period's commitments for capacity to be obtained from the Company. Such changes may be accepted to the extent that the aggregate percentage of Sellers' total requested capacity requirements to be obtained from the Company under the Program neither increases nor decreases more than 20 percent from the aggregate percentage of Sellers' total capacity requirements obtained from the Company for the prior capacity release period. If the aggregate percentage of Sellers' total requested capacity requirements to be obtained from the Company would result in an increase or decrease of more than 20 percent from the aggregate percentage of Sellers' total capacity requirements obtained from the Company for the prior capacity release period, the Company may adjust proportionately the amounts of capacity requested to be released by the Sellers.

At any time during a capacity release period, if a Capacity Release Seller requests a change in the amount of capacity released to it from the Company as a result of a change in the total MDQs required by all of its Firm Transportation Customers, the Company will accommodate the request change subject to its discretion to limit the additional amount of capacity to be released to a Capacity Release Seller or other persons if such capacity is not available for release or cannot be acquired.
