##### **7. Retail Access Capacity Program**

###### **d) Administration of Released Assets**

After the initial release of assets, the Distribution Provider shall administer release of assets so as to maintain a correspondence between winter season design day requirements of the retail load served by each Distribution Customer and capacity released to that Distribution Customer on a periodic basis. As load served by a Distribution Customer changes, the Distribution Provider shall periodically make corresponding adjustments to the quantity of capacity released to the Distribution Customer. The procedure for effectuating such adjustments is specified in the Distribution Provider's GTOP manual. In any situation where the Distribution Provider is required to repute the recalled capacity entitlements to the Distribution Customer, the Distribution Customer waives its rights to such repurchases.

###### **e) Recall of Capacity Entitlements**

If the Distribution Customer becomes unqualified to sell gas on the Distribution Provider's system or transport gas on pipelines upstream of its city gates, the Distribution Provider shall recall all capacity released to the Distribution Customer. If the Distribution Customer fails to deliver supplies of gas adequate to serve its Retail Customers, or if required for system reliability purposes, the Distribution Provider shall have the right to recall all capacity released to the Distribution Customer. References to "recall" of capacity are intended to include all returns to the Distribution Provider of rights and obligations pertaining to capacity previously released to a Distribution Customer, unless the context requires otherwise.

###### **f) Release of Empire Capacity**

Release of capacity on Empire will be carried out pursuant to the terms and conditions of Empire's Tariff on file with the Commission, as such Tariff may be amended from time to time, and the terms and conditions of any separate agreement between the Distribution Provider and Empire pertaining to this subject. In the event of any conflict between the terms and conditions of Empire's Tariff and any separate agreement, the terms and conditions of the latter shall control. Release of capacity on TCPL and Union shall be carried out by the Distribution Provider consistent with the terms and conditions of the Distribution Provider's agreements with TCPL and Union.

###### **g) Release of DTI Capacity**

Release of capacity on DTI shall be carried out in a manner consistent with FERC requirements pertaining to capacity release.

###### **h) Rates for Released Capacity**

The rates to be paid by a Distribution Customer taking released capacity shall be the Distribution Provider's maximum contract rates pursuant to the tariffs and/or agreements applicable to the released capacity.
