## D. EXTENSION AND MAINTENANCE OF DISTRIBUTION PROVIDER FACILITIES (Cont'd)

# (1) Distribution Provider Obligations - Street Lighting (Cont'd)

- (d) Rearrange its existing distribution facilities and/or extend new distribution facilities, as required, when the Distribution Customer notifies the Distribution Provider of its desire to attach a new fixture to, or relocate an existing fixture on, an existing wood pole, provided that the Distribution Provider's engineers determine such work is feasible and the Distribution Customer pays the Distribution Provider's costs and expenses incurred in the rearrangement and/or extension of distribution facilities. The Distribution Provider shall provide an estimate of such costs and expenses to the Distribution Customer prior to performing such rearrangement. Should it be determined by the Distribution Provider that in order to accommodate such an attachment an existing pole must be replaced to comply with existing Distribution Provider or industry standards, the Distribution Customer shall, in addition to any rearrangement costs, pay the installed cost of the new pole, plus any removal costs, less the percentage depreciation applicable to the old pole and any salvage value.
- (e) Have the right, but not the duty, to inspect and to discontinue service to any Distribution Customerowned or Retail Customer-owned equipment which, in the opinion of the Distribution Provider, shall have become unsafe for further service for any cause beyond the Distribution Provider's control, and give prompt notice of such discontinuance to the Distribution Customer.

#### (2) Distribution Provider Obligations - Traffic Signals

When a written request for traffic signal distribution service is made to the Distribution Provider by a Distribution Customer, the Distribution Provider shall:

(a) Designate the character of service and service connection point(s), and, if necessary, extend its distribution facilities to such point(s) of service and charge the Distribution Customer the Distribution Provider's costs and expenses (excluding transformers, accessories and switching equipment) for such distribution facilities.

#### (3) Distribution Customer Obligations - Street Lighting

When a Distribution Customer submits a written application to the Distribution Provider for street lighting distribution service, the Distribution Customer shall:

(a) Inquire of the Distribution Provider as to the point(s) of service, character of service to be rendered and the acceptability of the type and location of equipment to be attached or connected to the Distribution Provider's facilities, prior to installing, or having installed, street lighting facilities to be served under this Tariff.
