SERVICE-POINT DISTRIBUTION SERVICE (Cont'd)

SPECIAL PROVISIONS: (Cont'd)

Service Classification No. 12 Power for Jobs Rate

1. **Applicable to Use of Service For:** All purposes, in entire control area, beginning on November 1, 2000, by any Retail Customer which meets the criteria listed in Section 5. Retail Customer Eligibility Criteria, below.
2. **Purpose:** This service classification is designed to implement the provisions of Chapter 316 of the New York Laws of 1997, which authorizes certain allocations of firm power and energy generated at the New York Power Authority's ("NYPA's") James A. Fitzpatrick Plant and purchased under a competitive procurement process (referred to in this tariff as "Power for Jobs"). Such implementation is conditioned upon entry by the Distribution Provider and NYPA into a "Power for Jobs Purchase and Resale Agreement" and upon the physical availability of Power for Jobs.
3. **Definitions:**
 - a) "Parent Service Classification" shall mean the service classification in this Tariff that would apply to the Retail Customer service point in the absence of a Power for Jobs allocation. For purposes of this Service Classification, Service Classification Nos. 3, 7 and 8 are eligible to qualify as Parent Service Classifications.
 - b) "Power for Jobs Contract Demand" shall be the level of demand specified in the Retail Customer's Power for Jobs allocation which NYPA is contractually obligated to supply.
4. **Term:** Service under this service classification shall continue for a term not to exceed three years and, in no event shall such term exceed that specified in the Retail Customer's fully approved Power for Jobs allocation by EDPAB. At the end of the three year term or the term specified in the Retail Customer's fully approved Power for Jobs allocation by EDPAB, or in the event that the Retail Customer's Power for Jobs allocation is withdrawn, the Retail Customer's entire load will be transferred to service under the Parent Service Classification.
5. **Retail Customer Eligibility Criteria:** To receive service under this service classification at a given service point, the Retail Customer must have received a recommendation from the Economic Development Power Allocation Board (EDPAB), together with all additional approvals pertaining to such recommendation, that pursuant to Chapter 316 of the New York Laws of 1997 qualifies the Retail Customer to receive an allocation of Power for Jobs from NYPA for that service point, and remain in compliance with any applicable requirements therein. Service under this service classification may be terminated at the Distribution Provider's option for a material breach of any the provisions of this service classification, if after ten (10) calendar days from the occurrence of the breach the Distribution Customer fails to take appropriate action to cure the breach, or if the Retail Customer loses its eligibility for the NYPA Power for Jobs allocation.
6. **Enrollment:** To enroll a service point for service under this service classification, or, in the case of a service point that is already enrolled with the Distribution Customer under another service classification, the Distribution Customer must request service under this service classification. The Distribution Customer must include with its request documentation that the Retail Customer has an approved Power for Jobs allocation from NYPA.
7. **System Benefit Charge:** The rates and charges under this Service Classification are increased by the applicable system benefits charge, as mandated by Public Service Commission Order, shown in the System Benefits Charge
