**L.1 BUSINESS DEVELOPMENT RIDER** (Cont'd)

shall be eligible to take service under Service Classification Nos. 3, 7, 8 or 9 of this Schedule and to pay for such service in accordance with the applicable Special Provision. Service supplied thereunder shall not be used to supply any of the customer's existing facilities. Service must commence within 90 days of the agreed upon start-up date of the new facility.

Where a customer adds at least 50 kW of demand to the Company's system and, in the opinion of the Company, said additional load cannot be feasibly metered, the customer may elect to have the applicable Special Provision discount applied to the monthly kilowatthours in excess of a base amount of monthly kilowatthours which have been determined by the Company using an annual historical period, provided, however, the customer meets all of the other qualifications set forth above. Each month, the excess kWh qualifying for the Rider will be limited to 730 hours times the nameplate or rated demand of the equipment initially installed to qualify for the incentive.

Applicants for service under this business development rider will be accepted until such time that the Company notifies the Commission that the cost of providing such service will become a burden to the other customers.

New service under this rider will no longer be available after May 11, 1995. Customers taking service under this rider on or before such date will continue to pay for service in accordance with the applicable Special Provision under Service Classification Nos. 3, 7, 8 or 9 until their original five-year term expires. This information is also set forth under the applicable Special Provision under Service Classification Nos. 3, 7, 8 and 9.

**L.2 ECONOMIC DEVELOPMENT ZONE RIDER**  
**PURPOSE:**

This service is provided in cooperation with the New York State Department of Economic Development, New York State Department of Labor, the New York State Public Service Commission, and the local economic development zone certification board, pursuant to Article 18-B of the General Municipal Law, to assist in the revitalization of economically distressed geographic areas throughout the Company's service territory.

**ELIGIBILITY CRITERIA:**

Any customer who locates to or expands in certified economic development zones and:

- (1) Who qualifies for service under and in accordance with the provisions of Service Classification Nos. 2, 3, 7, 8 or 9, and
- (2) Who has been certified by the local Economic Development Zone Administrator, described in Article 18-B of the General Municipal Law, as being eligible for this service, and
- (3) Who has provided the Company with documentation of such certification, and
- (4) Who permanently increases their demand or annual energy usage by twenty-five percent shall be eligible to receive rates hereunder.
