**SERVICE CLASSIFICATION NO. 2****STREET LIGHTING SERVICE - CUSTOMER-OWNED EQUIPMENT****APPLICABLE TO USE OF SERVICE FOR:**

Lighting of public streets, roads, alleys, ways and highways, and the outdoor lighting of public parks and playgrounds, and of public school district property, in Entire Territory, within the jurisdictional limits of the customer when, and to the extent, requested by the customer, with street lighting facilities which are owned or leased, and maintained, by the customer.

**CHARACTER OF SERVICE:**

Unmetered, Alternating Current 60 cycle, voltage and phase at Company's option, as available and appropriate for customer's requirements. Customer may use: (a) 24 hour burning lamps; or (b) install controls for dusk (one-half hour after sunset) to dawn (one-half hour before sunrise), and at other times of abnormal darkness, illumination approximating 4200 hours per year; or (c) install controls for dusk (one-half hour after sunset) to 1:00 a.m., illumination approximating 2024 hours per year.

**RATE CHOICES AVAILABLE TO CUSTOMERS:**

Pursuant to Rule 11, General Retail Access – Multi-Retailer Model, of the Company's Schedule for Electric Service, P.S.C. No. 19, customers served under this Service Classification will choose either a Retail Access Rate or a Non-Retail Access Rate.

**Retail Access Rate:** (Per Month)

RG&E will provide Delivery Service under the Retail Access Rate. Commodity Service will be provided by an ESCO. The Retail Access Rate is equal to the Non-Retail Access Rate minus (1) a Retailing Backout Credit of \$0.004 per kWh, and (2) the Market Based Backout Credit (MBBC) as described in Rule 11.C.13 of the Company's Schedule for Electric Service, P.S.C. No. 19.

**Non-Retail Access Rate:** (Per Month)

RG&E will provide Delivery and Commodity Service under the Non-Retail Access Rate.

**Determination of kWh Consumption:**

The kilowatthours consumed during the month shall be determined by multiplying the number of lamps connected for the full calendar month by the "Wattage" shown for each lamp by the number of burning hours in the month shown below and dividing by 1000, plus or minus the kilowatthours for lamps connected or disconnected for periods greater or less than a month, on a pro rata basis. If the customer installs a lamp type not listed in this tariff, the customer shall provide the necessary fixture specifications to the Company to allow the Company to calculate the wattage.

**Monthly Burning Hours:**

The monthly burning hours for each category of lamp are as follows:

24 hour burning	730
Dusk to Dawn	350
Dusk to 1:00 am	169
