Customers who qualify, under the Economic Development Zone Incentive (EDZI) in Section 7 of the General Information section of this Schedule, to receive an incentive for usage qualified prior to 10/01/04 will have their service bills reduced for qualified usage over 100 Therms per month for a term of ten (10) years, beginning on the date of the qualifying equipment installation and operation (unless the customer's initial zone certification becomes invalid), notwithstanding the expiration of the designation of an Economic Development Zone in the area where the customer is located. The reduction will be based on the following discount rates by Area for such qualified Therms in excess of the base amount established for each monthly billing period (as described in General Information Section 7 of this Schedule):
