##### **ELIGIBILITY CRITERIA** (Contd.)

- (4) Whose facilities are classified under one of the following Major Groups of Division D - Manufacturing, by the Standard Industrial Classification Manual: 20 - Food and Kindred Products, 21 - Tobacco Products, 22 - Textile Mill Products, Apparel and Other Finished Products Made from Fabrics and Similar Materials, 24 - Lumber and Wood Products, except Furniture and Fixtures, 25 - Furniture and Fixtures, 26 - Paper and Allied Products, 27 - Printing, Publishing and Allied Industries, 28 - Chemicals and Allied Products, 29 - Petroleum Refining and Related Industries, 30 - Rubber and Miscellaneous Plastics Products, 31 - Leather and Leather Products, 32 - Stone, Clay, Glass and Concrete Products, 33 - Primary Metal Industries, 34 - Fabricated Metal Products except Machinery and Transportation Equipment, 35 - Industrial and Commercial Machinery and Computer Equipment, 36 - Electronic and Other electrical Equipment and Components, except Computer Equipment, 37 - Transportation Equipment, 38 - Measuring, Analyzing, and Controlling Instruments, Photographic, Medical and Optical Goods, Watches and Clocks, or 39 - Miscellaneous Manufacturing Industries;

shall be eligible to receive service hereunder, provided that the customer shall apply for service under this rider prior to the addition of the load described in eligibility criteria (3), above.

The Company shall determine that the customer has added the requisite amount of load to make it eligible for service under this rider by either separately metering the customer's additional load, or at its option, by metering the customer's entire load and subtracting out a monthly demand baseline which has been determined by the Company using an annual historical period.

An electric customer who submeters electricity to tenants who meet the eligibility requirements of this rider is eligible for Incremental Manufacturing Load Rider rates for the submetered portion of that customer's purchases which supply such tenants.

##### **CHARACTER OF SERVICE:**

Continuous, alternating current - 60 cycle, voltage and phase at the Company's option, as available and appropriate for the customer's equipment.
