SPECIAL PROVISIONS:

(a) Seasonal Service:

This special provision is applicable only to customers served under the NYSEG Fixed Price Option (FPO) rate or ESCO Option with Supply Adjustment (EOSA) rate.

Upon request, customers who, during a period of six or more consecutive months, make only occasional (compared to the balance of the year) or no use of electric service at their premises may have their service maintained throughout the period, not to exceed eight months, and will be billed for the kilowatt-hours consumed during this period at the following unit price per kWh:

Such revised rate will be utilized only if greater than the initial FPO rate effective January 1, 2005. However, the revised rate will be applicable only to a customer who chooses or is placed on the NYSEG Fixed Price Option (FPO) rate or the ESCO Option with Supply Adjustment (EOSA) rate, on or after the effective date of the revision. The revised rate remains in effect for such customers through December 31, 2006, regardless of whether the customer chooses the FPO rate or EOSA rate.
