SERVICE CLASSIFICATION No. 13M (Cont'd)

MONTHLY METERED TRANSPORTATION (MMT) SERVICE - Continued

RATES:

SC 13M Customers who elect by September 1, 2005 to receive service under SC 13D, sign a Service Agreement and commence SC 13D service by April 1, 2006 shall be charged the Monthly Metered Transportation Transition rates ("MMT Transition Rate") through the earlier of SC 13D service commencement or April 1, 2006. The transportation charge rates for purchased gas cost recovery shall be reduced by \$0.05352 per Mcf for all volumes over 1 Mcf delivered to the Customer for TC-1.1, TC-2.0, TC-3.0 or TC-4.1 Customers and \$0.01552 per Mcf for TC-4.0 Customers.

For August 2005 the rates charged under this Service Classification for purchased gas recovery shall be reduced by \$0.05352 per Mcf for all volumes over 1 Mcf delivered to the Customer for TC 1.1, TC 2.0, TC 3.0 or TC 4.1 Customers and \$0.01552 per Mcf for TC 4.0 Customers.

1. Minimum Charge

The monthly minimum Charge ("MC") applicable to Customers in the following classifications are given below:

The monthly MC shall include the transportation charge for the first Mcf of gas transportation by the Customer. All Customers billed by the Company will be charged \$2.00 per bill.

MC-1.1	Customers with a maximum annual capability of burning Between 5,000 and 25,000 Mcf for the period:	\$ 321.94 per month
MC-2.0	Customers with a maximum annual capability of burning between 25,000 and 55,000 Mcf:	\$ 705.83 per month
MC-3.0	Customers with a maximum annual capability of burning between 55,000 and 150,000 Mcf:	\$1,713.42 per month
MC-4.0	Industrial Customers with a maximum annual capability of burning greater than 150,000 Mcf:	\$3,696.30 per month
MC-4.1	Non-Industrial Customers with a maximum annual capability of burning greater than 150,000 Mcf:	\$3,365.80 per month

2. Transportation Charge

The default Transportation Charge ("TC") rate per Mcf for all volumes over 1 Mcf delivered to the Customer shall be as listed below, which includes \$0.14632 per Mcf for TC-1.1, TC-2.0, TC-3.0 or TC-4.1 Customers and \$0.05332 per Mcf for TC-4.0 Customers to recover purchased gas costs.
