to the WBSS for that Winter Period. At any other time during the Winter Period, the availability of additional WBSV allocations to Marketers will be made at the Company's sole discretion.

- c) If the Company elects, in its sole discretion, to make any additional WBSV allocations to new or participating Marketers, it will do so pursuant to a process set forth in the Company's Sales and Transportation Operating Procedures Manual.
- d) During the Winter Period, the Company shall deliver to the Citygate the Marketer's subscribed WBSV in equal daily amounts, including an amount to be retained as an allowance for losses based on the Schedule set forth below.

- e) WBSS participants will be subject to a bundled rate for WBSS gas purchased in addition to any applicable charges as set forth under SC Nos. 9 and 20 and General Information Section VIII of this Gas Rate Schedule. The monthly WBSS rate shall be designed to recover commodity costs, firm and variable transportation costs, storage costs, and carrying charges on the cost of WBSS gas, which shall be determined by using the effective Other Customer Capital Rate prescribed by the Commission. Storage costs shall consist of fixed demand and variable fuel costs, including associated costs for space, deliverability, injection and withdrawal, for pipeline storage facilities for the applicable period at the rates and charges of each applicable pipeline. Variable transportation costs shall consist of variable costs and fuel costs for transportation associated with gas deliveries from one or more production area storage facilities to the Company's Citygate. All costs used in determining the WBSS rate will explained in the Company's Gas Sales and Transportation Operating Procedures ("Operating Procedures").
- f) The bundled rate for the WBSS shall be as set forth in the "Statement of Balancing Service Charges Applicable to SC Nos. 9 and 20".
- g) WBSS will be provided in accordance with the terms and provisions of this Service Classification, the Operating Procedures, and an agreement between the Company and the WBSS participant.
