First 800 CF per bi-monthly period \$2.940 per 100 CF  
 Next 1,200 CF per bi-monthly period \$3.732 per 100 CF  
 Next 6,000 CF per bi-monthly period \$1.603 per 100 CF  
 Over 8,000 CF per bi-monthly period \$1.130 per 100 CF
