SPECIAL PROVISIONS: (Continued)

- F. Customer's equipment and wiring shall be approved by a competent inspection agency. The unit installation shall comply with Company specifications and be approved by the Company. The Company may restrict the type of equipment to be installed on existing Company equipment. Connection to Company's system shall be made only by Company's personnel or its designees.
- G. Company shall have the right to discontinue service to any customer owned equipment which in the opinion of Company shall have become unsatisfactory for further service by reason of deterioration, civil commotion, state of war, explosion, fire, storm, flood, lightning, or any other cause reasonably beyond Company's control.
- H. Company shall use reasonable diligence to provide a continuous regular and uninterrupted supply of service, and in event of an interruption, Company shall make all reasonable efforts to restore service promptly.
- I. The customer shall be responsible for providing to the Company a location equipment inventory for specific locations as identified by the Company representing a partial apportionment of the total locations. Such inventories shall be conducted on an annual basis whereby all locations shall be inventoried on a three year cycle.
- J. Audits of customer equipment, partial or complete, may be conducted by the Company. If audit results determine that a change in equipment has occurred without notification to the Company, the Company shall notify the customer of the audit results, adjust the customer's inventory records, and apply the adjustments to correct future billings. If audit reveals inaccurate reporting of customer's equipment, the Company shall have the right to meter those customer traffic control location(s) whereby the meter and installation costs are the responsibility of the customer. The customer may request meter service. Meter service, initiated either by the Company or customer, shall be served under Service Classification No. 2 of the General Electric Tariff.
- K. If line extensions are required, Company shall install the required line extension at the expense of the applicant. If other customers are attached to the line extension within a five-year period, Company will refund to the applicant on the basis of Rules 15, 16 and 17 of the General Electric Tariff.
- L. In the event of changes or revisions of this service classification, customer shall take and pay for service in accordance with the provisions of the revised or superseding service classification. Charges to customers shall be prorated between the superseding and the superseded rate on the basis of the actual number of days in the billing period, with the superseding charges applying to the days of service taken on or after the effective date of such change.
