Statement of Unbundled Transportation Service Cash Out Charges

Not less than four business days following the effective Month, the Company will file with the Commission a Statement of Unbundled Transportation Service Cash Out Charges, which statement will contain the following charges applicable to this Service Classification: Monthly Average Commodity Cost of Gas and ICOG; Daily Commodity Cost of Gas and Daily ICOG.

Actual Monthly ICOG - The actual monthly incremental cost of gas including demand charges incurred by the Company as be determined by the Company.

Monthly Average Commodity Cost of Gas - The Company's weighted average commodity cost per therm of gas delivered to the city gate facilities from the Company's suppliers for the month as determined by the Company.

Daily Commodity Cost of Gas - The Company's daily commodity cost per therm of gas delivered to the city gate facilities from the Company's suppliers on such day as be determined by the Company.

Daily ICOG - The daily incremental cost of gas, including demand charges as This cost will be determined by the Company.

Statement of Unbundled Transportation Service Charges:

Not less than three (3) days prior to its effective date, the Company will file with the Commission a Statement of Unbundled Transportation Service Charges, which statement will contain the following charges applicable to this Service Classification: Daily Swing Service Demand Charge and UTC.

Special Provisions:

- (a) Subject to Terms of Service Classification No. 5: Sellers that execute a Seller Agreement under this Service Classification are bound by the applicable provisions of Service Classification No. 5.
- (b) Remote Reading Devices: Each Customer has the option of having a remote reading device installed for service under Service Classification No.5. Sellers that contract to sell natural gas to Customers electing not to have a remote reading device installed agree to accept the accuracy of the company's estimates for calculating a customer's DDQ.
- (c) Regulatory Approvals: Sellers shall make all necessary arrangements, obtain all necessary regulatory approvals and be responsible for all costs including taxes to appropriate governmental entities for the acquisition and transportation of the gas supply delivered to the company's City Gate on behalf of a Customer or an aggregation group.
- (d) Errors in Calculating DDQ or ADDQ: A Customer that takes service under this Service Classification accepts the company's calculation of the DDQ or ADDQ. The Company shall not be liable for errors in the calculation of the applicable DDQ and/or ADDQ.
