Change in Supplier

1. A customer may change Marketers effective on the 1st day of any month by providing to the Company Supplier Select Form 2 not later than 10 calendar days prior to the month service is to commence. Service will not commence, however, until the next scheduled meter reading date. For a 31 day month this will be on the 22nd of the month, for a 30 day month this will be on the 21st of the month, for a 29 day month this will be on the 20th of the month and for a 28 day month on the 19th of the month. Supplier Select Form 2 must be completed by the customer's new Marketer and submitted to the Company electronically through the Company's Web site. The Company will acknowledge receipt of Form 2 via the "add/drop" report posted on the Company's Web site.

Load Aggregation Service

1. Pooled Balancing Service

Pooled Balancing Service permits a Marketer to pool the usage of a group of eligible customers for the purpose of determining imbalances.

- a. <u>Customer Eliqibility</u>. Pooled Balancing Service is available to customers served under Service Classifications 5 Non-DCA, 7 Non-DCA, S.C. 8, S.C. 5I and S.C. 9 (contracts with effective dates before June 1, 1996 will have to amend their existing service agreements in order to participate in Pooled Balancing). To receive Pooled Balancing Service, Supplier Select Form 2 must be completed by the Customer*s approved marketer and submitted to the Company electronically through the Company*s web site or via fax not later than 10 calendar days prior to the month service is to commence. For a 31 day month this will be on the 22nd of the month, for a 30 day month this will be on the 21st of the month, for a 29 day month this will be on the 20th of the month and for a 28 day month on the 19th of the month.
- b. <u>Direct Customer</u>. To receive Pooled Balancing Service the Direct Customer must complete Customer Form 1 and submit it to the Company electronically through the Company*s web site or via fax not later than the 21st of the month prior to the month service is to commence.
