SERVICE CLASSIFICATION No. 4 (Cont'd)

SUPPLEMENTAL SERVICE - Continued

The M.D.V. is established at the Customer's peak daily usage for the first winter month (December, January or February) that the Customer receives service under this service classification. Once the M.D.V. is established by the Customer's usage, it shall remain in effect for a twelve-month period. In the event that the Customer subsequently exceeds the M.D.V. during the calendar months December, January or February, then the M.D.V. shall be reestablished at the higher volume. The reestablished M.D.V. shall remain in effect, and shall be used for billing the Customer, for a twelve-month period starting with the billing month following the day it was established.

Volumetric Component -

For all gas delivered to the Customer, the Customer shall pay the "commodity cost of gas", as defined below, plus \$1.0043/Mcf for Customers previously served under SC 3. The "commodity cost of gas" is the weighted average commodity cost of gas delivered to the Company through upstream pipelines as calculated in the Company's monthly gas adjustment under General Information Section 19 above.

UTILITY LOW INCOME ENERGY EFFICIENCY PROGRAM (ULIEEP) SURCHARGE:

The rates in this Service Classification shall be increased by the ULIEEP surcharge, as described in General Information Section 39.

WEATHER NORMALIZATION ADJUSTMENT:

Supplemental service rates shall be subject to a refund/surcharge per 100 cubic feet as set forth in Section 36, General Information.

TAKE OR PAY RECOVERY:

Supplemental service rates shall be subject to a surcharge per Mcf as set forth in Section 38, General Information.

TRANSITION SURCHARGE:

Rates under this Service Classification shall be subject to the Transition Surcharge per 100 cubic feet as described in General Information Section 42.

RESEARCH AND DEVELOPMENT SURCHARGE:

Rates under this Service Classification shall be subject to the R & D Surcharge per 100 cubic feet as described in General Information Section 43.

AGGREGATION BILLING CHOICE SURCHARGE:

Rates under this Service Classification shall be subject to the Aggregation Billing Choice Surcharge per 100 cubic feet described in General Information Section 44.
