GENERAL INFORMATION

9. Unmetered Service (if applicable and provided for in Service Class Nos. 1,2,3,4, and 7)

All applicable provisions of this tariff shall apply.

A.No additional fixture or alteration of any pipe or fixture, changing or affecting the use of water by flat rate customers shall be made by any customer without notice in writing to the company.

B.If at any time, upon inspection, fixtures, in addition to those previously reported to the Company, are found connected with the pipe system and available for use, payment for their use at the rates, as provided in the appropriate service classification, shall thereupon become due upon demand for the entire period elapsing since the last inspection by an accredited company inspector or for such period as can be satisfactorily proven to the company that the fixture has been in service (not to exceed 24 months).

C.Water is furnished for certain premises and for a certain specified sum. If, therefore, a customer furnishes other premises with water, or permit them to take water, or permits them to take water without the company's consent, or if he uses it for purposes not stated in his application, it is a violation of the company's filed tariff and the company shall make such charges as it has scheduled for such premises. No customer, by means of a hose or otherwise, shall supply any fixture such as a water closet or bath tub, from any other fixtures, unless the fixture supplied is paid for at regular rates.

D.Every fixture whether used or not will be deemed and held as used, and will be charged for at the rate prescribed in the appropriate service classification so long as it shall remain connected with the service pipes. A customer who desires to discontinue the use of any fixture must have the same disconnected so that it cannot be used again and then the charge for its use will cease from the time when written notice of the same is left at the company's office.

E.Water will not be furnished where pipes are inferior, the plumbing defective, or the faucets, water closets, or other fixtures leaking or imperfect, and when such conditions are discovered the supply of water will be cut off.

F.No alterations in pipes or fixtures shall be made and no additional fixtures put in without notice to the company, the only exception will be in cases where pipes have burst and damage to the premises is likely to result from any delay in making the application.

G.The use of hose is restricted to premises having a hose connection.

H.Lawn sprinkling must be done by hand.

10. Extension of Mains

Mains will be extended in conformance with Commission Rules and Regulations found in 16 NYCRR, Part 501.

11. Discontinuance of Service - Non Payment

Service may be discontinued under the following provisions: for non-payment of any amount due for water supplied, for failure to make any payment due under a deferred payment agreement or for meter repairs (see Section 8C), for failure to post a required deposit or for failure to pay any fee or charge accruing under the contract or tariff.
