In order to be eligible for the Retail Access Program, which is effective September 1, 1998, in addition to meeting the requirements set forth in the section above entitled Applicable to Use of Service For, customers must also meet the conditions set forth in General Information Section 35.A. Customers must adhere to the enrollment requirements set forth in General Information Section 35.B and, if not acting as their own retail supplier subject to the requirement set forth in General Information Section 35.A, must select a Retail Supplier who has met the conditions set forth in General Information Sections 35.E and 35.F. Customers may, at anytime, choose to change Retail Suppliers or return to the Company system pursuant to the terms and conditions of General Information Section 35.C.

CHARACTER OF SERVICE

Continuous, 60 cycle, single or three phase alternating current delivered at one secondary voltage or one primary distribution voltage, phase and voltage depending on availability and the customer's requirements.
