## 4. BALANCING RECEIPTS AND DELIVERIES OF CUSTOMER-OWNED GAS: (CONT'D)

## A. Daily Balancing (Cont'd)

- 1. Excess gas delivered to the city gate will be purchased from the Customer at the following rates: eighty percent (80%) of the Minimum Daily Gas Index per therm for all quantities between ten percent (10%) and fifteen percent (15%) deviation, plus seventy percent (70%) of the Minimum Daily Gas Index per therm for all quantities between fifteen percent (15%) and twenty percent (20%) deviation, plus sixty percent (60%) of the Minimum Daily Gas Index per therm for all quantities in excess of twenty percent (20%) deviation from nomination, plus;
- The Customer will pay for the cost of any storage injections at maximum prices for injection for all gas which has been over-delivered.
- B. Monthly Balancing For Daily Metered Customers

Customers with daily metering may elect monthly balancing in lieu of daily balancing subject to the following conditions:

- 1. Customer has elected Transportation Balancing Service in accordance with Service Classification No. 9 of this Schedule.
- 2. Each month, the Customer's aggregate consumption and deliveries to the Company's system of Customer-owned gas will be reconciled.
  - a. A negative imbalance exists when the Customer has aggregate consumption greater than that Customer's deliveries of Customer-owned gas to the Company. The Customer must pay for such negative imbalance at the applicable price specified in the service classification designated for the Customer's meter.
  - b. A positive imbalance exists when the Customer has consumption in a given month that is less than that Customer's deliveries of Customer-owned gas to the Company for that month plus any allowed positive imbalance from the previous month. The positive imbalance gas will be considered to be the first gas to be consumed in the subsequent month, and may constitute up to twenty-five percent (25%) of any daily nomination, except as provided in Section 4.C., below.
  - c. The table below details the allowed positive imbalance quantity and the charges which will be assessed when a customer's positive imbalance quantity exceeds the allowed positive imbalance quantity.
